

LETTER FROM THE EXECUTIVE DIRECTOR

2020 has been a very difficult year for many in our country. The COVID-19 pandemic and its impact on all aspects of our personal and professional lives is hard to calculate. As we reflect on the accomplishments that were achieved in 2020, we must also understand that the pandemic's effects will continue to be felt well into 2021 as well. However, despite the difficulties experienced during this most unusual year it is important to consider how much activity TRC was able to execute in the last year. The program continued to work in new and interesting ways to keep collecting mercury-containing thermostats and recycling every mercury thermostat every time.

While overall 2020 collections are down, data shows that the replacement of HVACR equipment continues to be the leading indicator to mercury thermostat replacement. The accelerated adoption of "smart-home" controls and the array of utility programs which encourage early thermostat replacements continue to be major drivers of collections. Looking ahead, TRC anticipates that the program will experience a rebound in 2021 collections as site visits can be utilized in a greater capacity to encourage the return of mercury containing thermostats. However, it is important to remember that TRC collects and recycles a product that has not been sold in the marketplace since 2007; and as there is a decreasing number of mercury-containing thermostats in use, our collections will continue to decline.

TRC was able to fulfill state statutory requirements, agreements and other arrangements for regulatory and legislative compliance, despite the strain our country experienced in 2020. In 2021, TRC will continue to target mercury thermostat collections with utility energy efficiency programs while simultaneously maintaining the HVAC industry collections. TRC plans to work with its partners in industry, the waste sector, the energy sector and the regulatory community to achieve positive results.

The message around the importance of the proper disposal of mercury-containing devices is really a familiar message. As with any recycling program, our goal is to maintain awareness of the issue without becoming background noise lost in the constant stream of marketing information broadcast

each day. One exciting change coming to TRC in 2021 will be a redesigned website, built to better target individual recyclers and homeowners as well as expanded mobility functions.

For a program such as TRC's to be successful year after year, the coordinated effort of many parties is required. TRC is fortunate to have exceptional support from its industry members, collection partners, marketers, allied industries, regulatory agencies and staff. These strategic partnerships allow TRC's effectiveness to grow as it continues to move forward successfully in the collection and proper disposal of mercury-containing thermostats.

CONNECTICUT

2020 Collections by Brand

In Connecticut, Thermostat Recycling Corporation (TRC) recovered the equivalent of 3,834 mercury thermostats from 2,240 whole mercury thermostats plus 1,577 mercury switches removed from thermostats. A total of 26.2 pounds of mercury was diverted from solid waste. *Please note the explanation of the converted thermostats or thermostat equivalents below.¹ An example of the mercury ampoule is shown below.



As required by the state statute, a table of thermostat brand holders with their corresponding thermostats, the number of switches and the pounds of mercury recycled is below. It is important to note that there remain non-members whose thermostats the TRC collection program recycles. They are listed in the table as "Non-Member Brands".

1

¹ A mercury thermostat contains a variable amount of mercury ampoules or "switches" attached to the subbase of the thermostat. These glass ampoules often are collected in the recycling container without the intact thermostat attached to them. TRC collects and counts these loose ampoules and recycles them. To derive the converted thermostat or thermostat equivalent, the program takes the following calculations to develop the converted thermostat or thermostat equivalent. First, TRC will count the total whole (intact) thermostats collected in the recycling bins. From these units, there is an intact ampoules count. TRC then takes the intact ampoules divided by the whole (intact) thermostats or otherwise known as the conversion ratio. After the conversion ratio is calculated, TRC will multiple the loose mercury switches by the conversion ratio. Lastly, we add this result to the whole (intact) thermostats to produce the converted thermostats or thermostat equivalents.

2020 Education and Outreach

Direct Marketing (Email, Mail, Other Communications)

Current Collection Locations

Small Pails and Green Bins

In 2020, TRC shipped 25 small pails to collection points around the country. We also shipped 159 new green bins. In comparison, the program shipped 291 new green bins in 2019 and 55 small pails². Collection locations either requested the new pail when they signed up to participate in the program or chose to switch out their bin with a pail due to decreased collections. The large green bins which have been the staple of the program continued to be replenished as they were returned for processing. Because the containers are reused and bar coded, we anticipate that the request for new containers will continue to decrease as the program operates.

• Of the totals provided, TRC shipped zero new small pails and four new large bins in the state.

Collection Location Outbound Phone Calls

Our outbound phone calls have been branded internally as the "Miss You Call" process. These calls promote collection container returns and serve as a reminder to locations that have not returned any thermostats. TRC allocates these "miss you calls" to collection sites that have not returned a container in over a year. These calls serve as a friendly customer service check to see if any of the program materials need to be replenished or if missing containers need to be replaced. In total, the program called 4,175 current collection locations in 2020, compared to 3,557 in 2019.

• Completed 220 calls to encourage shipping the recycling container compared to 193 a year prior. A copy of the locations called can be found in the Appendix.

Collection Location Postcards

TRC updated the reminder postcard design mid-2019 to encourage locations to heed the message. The postcards are sent to all locations that have not returned a container in the past year. In 2020,

² New bin orders coincide with accounts that open new stores, move or lose their existing containers.

TRC mailed 12,963 postcards. By updating the look of these postcards, TRC hoped to engage locations that were familiar with the old design and may have disregarded it in the past.

Mailed 422 reminder postcards compared to 383 a year prior.



Collection Location Emails

TRC emailed locations three weeks after receiving a postcard to encourage them to directly ship the recycling container. These emails contain step-by-step instructions for shipping and direct contact information for missing shipping labels or further questions.

• Emailed 95 collection locations three weeks after receiving the reminder postcard to ship their container.

Collection Location Site Visits

Throughout the year, 1,781 site visits were completed in numerous states. The purpose of site visits is to inform the location of their requirements in participation, what the statute requires of them, shipment of the recycling container, and to answer any questions they may have. Often, valuable information is gathered during the site visit which is used to enhance TRC's outreach and update the database with current contact details. With the pandemic, TRC refrained from visiting locations inperson for a few months. For locations scheduled to receive a visit between March and August we "virtually visited" those locations via phone or meeting, rather than cancelling the visit altogether.

Visited 33 collection locations compared to 50 in 2019. A copy of the sites visited can be found
in the Appendix.

HVAC Industry

The HVAC industry is arguably still the best, most productive and most engaged channel for recycling mercury containing thermostats. We consider this industry to be the manufacturers, wholesale distributors, and contractors which are intimately involved with the recovery of mercury thermostats. TRC took the following actions:

- TRC was spotlighted in HVAC Refrigeration Daily, a print magazine distributed at the International Air-Conditioning, Heating, Refrigerating Expo.
- Continued the "Banish Mercury Off the Planet" (BMOP) Competition encouraging all HARDI wholesalers to compete through collections. Included direct marketing to 2,714 HARDI HVAC members.
 - The annual competition recovered 222.95 pounds of mercury from 166 HVAC wholesalers. More than 350 branch locations returned collection bins during the contest period.



- TRC appeared on radio shows to promote the program and National Recycle Your Mercury
 Thermostat Day. Both Hammertime Radio in Buffalo, NY and The Future of Real Estate in
 Tulsa, OK featured TRC and our mission in October of 2020.
- TRC was featured on Season 2, episode 43 of the HVAC Jerks Podcast titled "Mercury in the Green Box, Please". The episode focused on TRC's history, program and what the future holds.

Utility Industry

In 2020, TRC continued its approach to engage the utility sector, specifically targeting actions toward the utility companies themselves and the installer/implementer. Each of these audiences have distinct messaging requirements and informational needs.

 Exhibited at two conferences targeting the utility industry before the pandemic halted inperson events. • Sent 424 informational emails to known utility implementers on the program.

Waste Related Sector and Household Hazardous Waste (HHW) Industry

The waste-related sector remains an important sector for TRC to target individuals and those residents performing DIY thermostat installations. These attempts were to gain new collection locations, form better relationships with the audience and raise overall awareness of the TRC program. As a result of these learnings, TRC took the following actions:

- Scoured google alerts for HHW events to target phone call or email outreach to encourage them to use program. Sent 16 emails to facilities, offering a free container.
- Advertised in the national North American Hazardous Materials Management Association
 (NAHMMA) News Brief, reallocating funds planned for the conference.

Website

In 2020, TRC updated the zip code locator on the website to provide information regarding pandemic protocols. While most collection locations remained open, certain operations were most likely adjusted to accommodate for social distancing. Therefore, we recommended all recyclers should contact the collection location beforehand.

In the fall of 2020, TRC began a website redesign project that will enhance mobile accessibility and better navigation for website users. TRC expects to launch the updated website in the spring of 2021.


Search Engine Marketing (SEM)

Search Engine Marketing (also SEM or pay per click—PPC) is the process of buying a paid position on the search engine results page. TRC refined its strategy for SEM in 2020 with very promising results.

Impressions and clicks went down when compared to 2019, but the overall click-through-rate went up, which means a higher percentage of people are engaging with TRC's ads and that TRC is reaching the right audience.

The focus for TRC's SEM strategy is conversions, which are counted when someone navigates to the Find a Thermostat Collection Site page on the TRC website. In this area, there was very positive improvement for 2020 in the number of conversions, the cost per conversion, and the conversion rate.

In summary, overall, more qualified leads came to the TRC website in 2020.



Search Engine Optimization (SEO)


Search Engine Optimization (SEO) is the process whereby a website is optimized through original content and on-site coding tactics to increase its chances of appearing near the top of "organic searches." An organic search is one that appears "naturally" in a search engine like Google or Bing. In other words, an organic listing is not ranked through paid search.

Organic traffic to a website typically brings visitors who stay longer, and visit more pages, on average.

Two key measures were identified as a baseline for growth. They are:

- Clicks from organic search
- Page-one organic terms

In 2020, organic search traffic yielded 7,460 clicks to the TRC website. By comparison, there were 6,427 clicks from organic search over the same time period in 2019.



In 2020 TRC had 298 organic search terms ranked on page one of a Google search, a small decrease compared to 334 page-one keywords in 2019. As TRC goes through a website redesign in Q1 of 2021, SEO is being refreshed for enhanced performance moving forward.

2021 Program Modifications

Thermostat Recycling Corporation's 2021 Goals

TRC continues to set high-level annual goals for the organization. These goals assist in decision making and prioritization of activities. For the calendar year 2021, TRC plans to focus on:

- Continuing to fulfill state statutory requirements, agreements and other arrangements for regulatory compliance.
- Targeting mercury thermostat collections from utility programs. Maintain the HVAC industry collections. Other key audiences vary by state and requirements.
- Focusing on education and awareness tactics geared toward homeowners and HVAC industry professionals.

Thermostat Recycling Corporation's Planned Tasks

In addition to the above goals, TRC set specific tasks which we plan to focus on. Completion of these tasks aid in the overall organization's goals.

- Attend and integrate learnings from other EPR products after the biannual Product Stewardship in-person meetings.
- Roll-out public releases throughout the year.
- Continue the program's operational activities such as outbound phone calls, mailing reminder postcards, and visiting sites. Use collection data trends to target these initiatives.
- Attend trade shows and conferences³. Look for speaking opportunities at attended events.
- Review Google AdWords funding and reallocate funds to other platforms where it makes sense.
- Launch redesigned TRC website in Spring 2021.

³ Due to COVID-19, many tradeshows have continued to be postponed or cancelled. When events can resume in-person, TRC plans to take part and in the meantime attends virtually if applicable.

Thermostat Recycling Corporation's Collection Program in Connecticut

Mercury in the environment can have many deleterious effects when it enters waterway systems, causing genetic and developmental issues in wildlife, and immune and nervous system damage in humans. Products such as thermostats hold a relatively small quantity of metallic mercury encapsulated in a glass bulb, and if the enclosure is compromised, the contents may be released into the environment where microbes can convert this mercury into highly toxic organometallic compounds such as methyl mercury posing a threat to the environment. While the predominant sources of mercury include coal-burning power plants and gold mining, mercury pollution can also be attributed to improper disposal of mercury-containing commercial and consumer products including thermometers, switches, certain types of light bulbs - including fluorescents - and older-generation thermostats.

In response to this concern, major thermostat manufacturers created and funded the Thermostat Recycling Corporation (TRC) in 1998, and the organization now has takeback participants in 48 states, including 17 state programs that have imposed regulations on the sale and / or disposal of these thermostats. The Thermostat Recycling Corporation works on behalf of thermostat manufacturers to provide sufficient and convenient return channels for older mercury-containing thermostats to prevent these products from ending up in disposal facilities such as landfills and incinerators. In addition, many states have implemented sales restrictions, disposal bans and product stewardship statutes for products containing mercury to prevent mercury from entering the environment. Connecticut has recently joined a growing list of states that require thermostat manufacturers to ensure a disposal alternative for thermostats through implementation of a convenient take-back program.

The goal of this report is to provide for the Connecticut Department of Energy and Environmental Protection an evaluation of the TRC's effectiveness in meeting the goals and requirements of the take-back program it conducts in Connecticut under Connecticut Public



Act No. 12-54. Included in this report is a summary of the program's current operations, including its access to return channels and the characteristics of those channels, and how they are marketed and publicized. Resource Recycling Systems (RRS) has prepared this report as an independent third party to quantify and assess the effectiveness of the TRC program in meeting its obligations to provide a convenient return channel for diverting and capturing thermostats removed from service.

Methodology

Bin and thermostat receipts from 2020 were used to determine the collection performance of the TRC collection program in Connecticut, and this data was used in conjunction with historical program performance data including bin and thermostat submission data across Connecticut and all other states where TRC has operated collection programs. The calculation of program results based on this data was analyzed both for technical accuracy as well as for measuring program performance.



Connecticut Program Performance

The Thermostat Recycling Corporation (TRC) is a non-profit stewardship organization that facilitates and manages the collection and proper disposal of mercury-containing thermostats. TRC is supported by 30 manufacturers and provides a network of collection sites around the United States with the aim of keeping mercury out of the waste stream and protecting the environment. The following analytical report details the annual program performance for mercury thermostat collection in the state of Connecticut (CT) in 2020. A few of the program highlights for 2020 are included below:

- In 2020, the program **collected 26.2 lb of mercury** in Connecticut. Since 2008, mercury collected in the state has increased by an annual average of 21% per year. During the same period, the total mercury collected in the nation decreased by an average of -0.3% per year.
- The program collected **2,240 whole thermostats in 2020**, 40% more than the number collected at original implementation of Connecticut Public Act No. 12-54 in 2013. The number of thermostats collected annually in CT has increased by an annual average of 17% since 2008.
- The number of **whole thermostats collected per bin in 2020 on average was 40 thermostats**, greater than the 31 thermostats/bin collected in 2019 and equivalent to the national average of thermostats/bin.
- Counties returning the most bins and thermostats in 2019 were Hartford (22 bins, 1,168 thermostats), followed by Fairfield (15 bins, 381 thermostats) and New Haven (8 bins, 343 thermostats).
- In 2020, **15% of the partner locations returned at least one bin**, a participation equal to the national average.



- In 2020, a total of **33 site visits were conducted in Connecticut, and 220 'Miss You' calls were placed to channel partners to prompt bin returns**. Bin returns appear to be correlated to site visits, which increased by 14% over 2019.
- In addition to 2,240 whole thermostats, 1,577 loose switches were collected, bringing the total number of "thermostat equivalents" returned in 2020 to 3,834, a 47% increase from 2019.



SECTION 1: Program Analytics

Section 1 of this report examines the annual performance of the thermostat collection recycling program in terms of bins, thermostats, and mercury collected as well as the year-over-year progression of the program.


FIGURE 1.1: PROGRAM PERFORMANCE OVER TIME

On average, the program has **collected 17.1 lb of mercury** and **1,792 thermostats per year** since 2001. In 2020, the program **collected 26.2 lb of mercury from 2,240 whole thermostats and 1,577 loose switches**. Figure 1.1 displays the total number of bins, thermostats, and quantity of mercury collected in Connecticut since the beginning of the program.

Figure 1.2 displays the number of bins collected in Connecticut over time as well as the total number of bins collected nationally over the same period. Annual bin collections peaked nationally in 2015 and in Connecticut in 2017 at 101 bins, followed by a small decline in 2018, and collections dramatically declined in 2019, followed by a year of similar participation in 2020 at 56 bins, only 4% greater than the 54 bins returned the previous year.

Since 2008, the average of annual increases in mercury collected has been 21% in Connecticut. During the same period, the percentage change in quantity of mercury collected nationally averaged an annual decrease of 0.3% per year, with 2020 representing the largest single year-over-year decrease nationally at -35%. In 2020, the quantity of mercury collected in CT increased by 26% to 26.2 lb mercury collected, closer to the quantity collected in 2019. Figure 1.3 displays the total quantity of mercury collected in Connecticut over time as well as the annual percent increase (or decrease) in Connecticut and nationally since 2008.

Channel partners in Connecticut returned 2,204 thermostats to TRC in 2020. This represents an **32% increase from 2019**. The average of annual increases in thermostats collected in Connecticut is **17% since 2008**. The yearly change in rates for the U.S. averaged -1% over the same period. Figure 1.4 displays the total number of thermostats collected in Connecticut and nationally.



Figure 1.6 displays the monthly distribution of bins and thermostats returned in Connecticut over 2020. The months with the greatest number of bins returned were May (15 bins) and June (11 bins). The months with the greatest number of thermostats returned were May (556 thermostats), April (376 thermostats) and January (256 thermostats). June and September represented the lowest activity levels in terms of bin returns and thermostats.

The highest number of thermostats per bin was in **September (108 thermostats per bin)**, followed by **April (94 thermostats per bin)**. Figure 1.7 shows the average number of thermostats per returned bin per month for the year.

FIGURE 1.7: AVERAGE THERMOSTATS PER BIN RETURNED PER MONTH







Figure 1.8 displays the average number of thermostats returned per bin in the state and U.S. since 2003 in Connecticut. Nationally, the number of thermostats collected per returned bin has been generally trended lower in more recent years, with an exception to that trend in 2019, but the average fell again in 2020. In Connecticut, the average number of thermostats per bin collected in 2020 increased by 29% to equal to the national average at 40 thermostats/bin.

FIGURE 1.8: AVERAGE THERMOSTATS PER BIN OVER TIME IN CT AND NATIONALLY









Figure 1.9 plots the total bins returned over time along with the average number of thermostats per bin over the same period to illustrate the relationship between the two metrics. A statistical analysis found that there is a negative correlation between the number of bins returned and the number of thermostats per bin: as the total bin count increases, the number of thermostats per bin decreases. In 2020, a slightly greater number of bins was collected than in 2019, yet the number of thermostats per bin also increased nearly to 2017 levels which significantly increased the thermostats collected in the time period.

SECTION 2: Channel Partner Analysis

Section 2 of the report examines the partner locations in more detail. Most thermostats collected in the state were through **wholesalers** (72%), followed by **contractors** (22%) and only a very small fraction sourced from **hazardous household waste facilities** (HHW, 6%). HHW facilities contributed a much smaller fraction and total number (124) than in 2019 (325) or 2018 (200). Figure 2.1 shows the distribution of thermostats collected by location type in 2020.

FIGURE 2.1: THERMOSTATS COLLECTED BY LOCATION TYPE IN 2020








Figure 2.2 below displays the change in the number of bins returned by thermostat collection type over time in Connecticut, including 2020. Contractors in 2020 returned 7 bins, similar to 2019, but HHW returned only 4, half the quantity of bins relative to 2019. Wholesalers returned 43 bins to TRC, again the largest contributor by a significant margin.

In 2020, **34 (12%) locations** with a bin in the state of Connecticut sent back one bin for recycling, while **6 (2%)** locations returned two bins. One location returned three bins, and one location returned seven bins. The distribution is displayed in Figure 2.3.

In 2020, Hartford returned the greatest number of thermostats by far including 22 bins and 1,168 thermostats, followed by Fairfield (15 bins, 381 thermostats), New Haven (8 bins, 343 thermostats) and Windham (2 bins, 134 thermostats). Figure 2.4 displays the number of bins and thermostats returned by county in 2020.

TRC works with channel partners to successfully collect thermostats, and the following figures illustrate performance by partner. **Sid Harvey (330 thermostats)** returned the highest number of thermostats in Connecticut in 2020, followed by **R.E. Michel Co. (255 thermostats)** and **Plimpton & Hills Corp (244 thermostats)**. The low overlap between the highest participants in 2020 vs 2019 suggests that companies may have a pattern of returning thermostats that have been accrued in previous years. Figure 2.5 displays the top performing partners by total bins returned in 2020.

FIGURE 2.5: T-STATS BY TOP PERFORMING CHANNEL PARTNERS IN THE STATE



To boost participation, TRC conducted site visits to collection locations that may not have returned a bin recently. In 2020, 33 site visits were conducted and 220 'miss you' calls were placed to 166 different locations in Connecticut. All visits occurred in May 2020. Figure 2.7 displays the relationship between the number of site visits per month, bins returned per month, and the number of thermostats (shown in 100's) returned per month. Like 2019, site visits show significant impact on bin return activity, with 12 locations receiving only a visit equaling the number that returned a bin. However, 21 locations received a call and a visit and only one of those locations returned a bin. Fifteen bins were returned in May and 11 bins were returned in June, the top two months. In January, 7 bins were returned, and April and December yielding 4 bins.

FIGURE 2.7: RELATIONSHIP BETWEEN SITE VISITS AND BINS AND THERMOSTATS RETURNED PER MONTH






Figure 2.8 displays the relationship between the number of calls per month, the bins returned per month, and the number of thermostats (by 100's) returned per month. All calls were placed in July and November. The 133 "call only" locations in 2020 returned 7 bins total from 6 sites. From Figure 2.8, increases in bin returns do not appear to coincide with months during which calls were made, suggesting the calls had little impact on channel partner behavior.






Figure 2.9 examines the return rates of four groups – locations that did not receive a call or visit, locations that received at least one visit, locations that received at least one call, and locations that received both a call and visit. As mentioned above, calls continue to have a much smaller impact on returns than visits. Locations that only received a call had only a 5% active participation rate, equivalent to that of locations that received a visit and call. The rate of active participation (which refers to locations that returned at least one bin) in 2020 is significantly greater for locations that did not receive either a call or visit. On average, visited locations returned 1.67 bins per location, much higher rate than the previous two years), and the 21 locations that received both a call and a visit collectively only returned 1 bin.

SECTION 3: Comparisons to National and Other States' Data

To compare how the state collection partners performed in 2020, the national average for the number of bins returned per locations that returned at least one bin was calculated and compared to the state average since 2012. The average numbers of bins do not include locations that did not return any bins in a given year. It should be noted that when making comparisons, each state has different regulations, different mix of housing types, local policies, and incentives that may uniquely impact return patterns in that region. Overall, the average number of bins returned annually per location was lower in Connecticut than the U.S. average in 2018-19, but once again slightly higher in 2020.

FIGURE 3.1: AVERAGE NUMBER OF BINS RETURNED PER LOCATION PER YEAR






Figure 3.2 displays the locations in Connecticut that returned more than one bin each year since 2017. The top participants in 2020 were not top performers in 2019, indicating that many of the returns from 2020 represent carryover collections from 2019 and possibly earlier years.

Figure 3.4 displays total percentage of locations that actively participated in the program (active participation defined as sending back at least one bin) in 2020, for all the states that mandate thermostat returns reporting as well as the U.S. national average for all states (reporting and non-reporting). **In 2020, 15% of locations in Connecticut returned at least one bin** which exceeded the national average by a fraction of a percent. Similar to 2019, the state with the highest percentage of locations returning a bin in 2020 was Rhode Island (33%), but the level of participation was significantly lower in that state and across most other states in 2020, likely a result of the COVID-19 pandemic.

FIGURE 3.4: MANDATORY REPORTING STATES' PERCENTAGE OF LOCATIONS RETURNING A BIN IN 2020






Figure 3.5 compares the state and national rates for several analytics in 2020. These include: the total whole thermostats, bins, and loose switches collected, the number of thermostats collected by total locations and per actively participating locations, the number of thermostats per bin returned on average in 2020, the equivalent average, the number of mercury thermostat equivalents returned, and finally the percent change in mercury thermostat equivalents from 2019 to 2020. The equivalent average is an average of the number of switches in whole thermostats collected in the state, and it is used to calculate the number of thermostats represented by returned loose switches. The thermostat equivalent number includes the totals of whole thermostats returned plus the equivalent number of thermostats representative of loose mercury switches that are collected. The states displayed are those that mandate thermostat returns reporting and the U.S. average is for all states that return bins (reporting and non-reporting).

Figure 3.6 further compares this state and national data by showing how each state ranked in each of these categories from highest to lowest. Bin returns and whole thermostats collected were slightly higher than 2019. However, loose switch collection was exceptionally high in CT in 2020, resulting in Connecticut's 2020 program achieving a higher ranking in terms of thermostat equivalents collected and the highest percent change in thermostat equivalents over 2019 of all regulated states. The states compared in Figure 3.6 are those that mandate thermostat returns reporting, and the U.S. average by contrast illustrates all states that return bins (reporting and non-reporting).

Figure 3.7 below shows the quantity of mercury collected through TRC's program in Connecticut and neighboring states between 2013 and 2020. While collection of mercury in Connecticut in 2020 decreased in 2019, overall mercury collection in 2020 increased by approximately 25% relative to 2019.

FIGURE 3.7: MERCURY COLLECTION RELATIVE TO PEER NEW ENGLAND STATES







Figure 3.8 illustrates thermostat collections increasing in CT in 2020 and the sharp contrast relative to other New England states, each of which declined significantly in 2020 relative to 2019 and in some instances by wide margins, including the largest collection state, Massachusetts, showing a decrease of 54% over 2019.

FIGURE 3.8: THERMOSTAT COLLECTION RELATIVE TO PEER NEW ENGLAND STATES






Thermostats and bin returns are two metrics measuring program participation that are correlated. In 2018 and 2019, the ratio of thermostats to bins declined after an increase from 2017. In 2020, the number of thermostats increased significantly while only two additional bins were collected. Figure 3.9 shows bins returned and thermostat collections concomitantly by year so relative rates of increase and decrease can be observed.

FIGURE 3.9: COMPARISON OF THERMOSTATS RETURNED VS BINS RECEIVED


CT Thermostats Returned vs Bins Returned





The average quantity of thermostats per bin is graphed in Figure 3.10 below, which illustrates the relationship more clearly between increased bins returned and increased thermostat returns. The average number of thermostats returned in a bin in CT declined consistently since 2012, however the rate rebounded in 2020 which was an aberration from the trend, but also the only increase in rate amongst the New England states shown.

Conclusions

Results in Year 7 of Mandatory TRC Program in Connecticut

The 2020 year was globally unique as a result of the COVID-19 pandemic, requiring businesses to modify operating behaviors and posing unanticipated impacts to many supply chains, including product and material recovery programs. Nationally, the pandemic's impact was reflected in a broad decline in TRC's channel partner program participation by way of the number of bin returns which fell to a level not seen since 2008, but also in terms of the number of total thermostats received, which plummeted in 2020 and reached the lowest level since 2004. Despite that trend nationally and regionally, partner participation rates in Connecticut did not see a significant year-over-year decline, managing to return 56 bins, which represents a small increase over 2019, albeit low relative to historical trends including the 93 bins collected in 2018.

A relative few CT channel partners have historically accounted for a significant fraction of total thermostat returns, which was also the case in 2020, with nine locations providing greater than half of all thermostats. The return pattern for total mercury, which accounts for loose switches in addition to thermostats, was even more pronounced in 2020 with only six locations returning to TRC over half the total mercury quantity collected. Three significant return events collectively yielded 1,455 loose switches and 229 thermostats for a total of 10.7 lb mercury. In total, the quantity of mercury increased by 26% in 2020 over 2019, in contrast to the concurrent overall U.S. 2020 trend, which experienced the largest year-over-year decline in two decades, falling 35 percent. Connecticut contractors returned more thermostats than they did in 2019, as did wholesalers, while HHW sites, which account for a very small fraction overall, returned fewer in 2020.

Analyzing the channel partner outreach efforts in 2020 and the impacts of those activities on the return of bins shows that site visits had an observable effect in prompting the return of bins. Those locations that received a site visit, yet no call, all returned a bin to TRC. When



considered together with 21 additional locations that also received a phone call in addition to a site visit, 13 out of 33 (39%) locations returned a bin, suggesting that visits are an effective tool for driving participation. Calls, by contrast had little effect on partner behavior. Only 6 (5%) of the 133 locations that received only a call returned a bin in 2020, and accounting for the 21 locations that also received a site visit, a total of 7 (4.5%) of the 154 locations that received a call returned a bin to TRC. The data suggests site visits are effective motivators for bin return activity while calls are not. However, the "Miss You" calls placed are targeted to locations that already have lower participation rates, so it would be expected that, given the lower participation of these locations overall that results will still be lower when compared to higher-performing locations which are not targeted by outreach in the same way. For example, of the 112 locations that received no visit or call, a significant fraction, 23 (21%), returned a bin unprompted.

The collection numbers in CT were down in 2019 relative to previous years, and there was anticipation that bins/thermostats not returned in 2019 may be collected in 2020. The 2020 channel partners with the highest participation did not have high participation rates in 2019, indicating that 2020 results do reflect a significant amount of carryover from 2019 and earlier, but due to market disruption it is also likely that a significant fraction of that inventory was not realized in 2020, with only 42 of approximately 280 locations returning a bin. While total bin returns only increased nominally in 2020, this occurred at a time when nearly every other state had significantly lower collection rates. As both consumers and the business community adjust in the wake of the pandemic and unreturned thermostats from 2021, it might be expected that collection activity will adjust back toward historical rates and combined with carryover bins/thermostats that were not realized in 2020, the CT program may see higher collections in 2021.

HOW MERCURY THERMOSTAT WASTE IS HANDLED

WASTE MERCURY-ADDED THERMOSTAT MANAGEMENT THROUGH VEOLIA ES TECHNICAL SOLUTIONS, LLC.

TRC containers with waste mercury-switch thermostats are received at a fulfillment/inventory center in Port Washington, Wisconsin (WIR000130591). The facility is owned and operated by Veolia ES Technical Solutions, L.L.C. (Veolia) under contract with TRC.

All recycling containers, including pails and bins are received at the loading dock and sent to the TRC inventory room. The container and plastic liner are opened and the contents are identified, sorted, and tallied. The following data is recorded for each bin returned and processed: bin number, business name (location name), city, state, zip code, date returned, number of thermostats and mercury switches by manufacturer and any non-conforming material.

The containers are returned to the location that sent it in with a new prepaid address label within 3 weeks of receipt. The thermostats are stored and staged in a plastic lined carton in a storage area for final processing. The containers are dated and processed in order received, first in-first out.

The thermostats and any loose bulbs collected from the containers are consolidated into a special 55-gallon drum which is labeled and dated according to regulations. The drum is sealed with a band and is only opened when contents are being added to it. Special negative pressure venting assures any fumes are captured and vented when the drum is opened.

The 55-gallon drum is then shipped to Veolia's mercury recovery facility (WID988566543) for final processing of the mercury ampules (switches). Veolia Environmental Services meets or exceeds all local, state, federal and EPA regulations for the management of the product.

The containers are returned from the storage area to the mercury recovery processing area to have the mercury bulbs removed from the plastic housing. Universal Waste Regulations require the recycling and disposal of waste within 12 months of acceptance at the processing facility.

Small quantities of thermostats are removed from the container, which is then closed again. The bulbs are removed from the thermostats and placed into processing vessel at the work station. Once the processing vessel is full, the vessel is loaded into the mercury recovery retort oven.

If a bulb breaks and the mercury spills, the work area is designed to contain the spillage and the operators are trained in the clean-up and disposal of mercury. The TRC inventory

and processing areas are equipped with special mercury vacuum cleaners and the work area is vacuumed at the end of the work day to ensure that any spillage is cleaned up and not left to evaporate.

Veolia meets or exceeds all local, state, federal and EPA regulations for the management of the product. The mercury recovery facility and process are permitted by the Wisconsin Department of Natural Resources. Veolia's approvals for mercury recovery/recycling include:

- EPA identification WID988566543
- Hazardous Waste Storage License #6008
- Hazardous Waste Treatment License (Mercury Recovery Operations) #4585
- Air Operation Permit #246076050-S01
- Storm Water General Permit #WI-S067857-4

In addition to the regulatory permits, both Veolia Port Washington facilities have developed and maintain management systems in accordance with ISO 14001-2004, OHSAS 18001-2007, and Responsible Recycling (R2:2013) Practice. All persons who handle mercury thermostats as part of the TRC operation receive training in the handling of Hazardous Waste and Universal Waste.

The mercury containing ampules are retorted at Veolia's Port Washington Mineral Springs facility. The mercury is removed during the retort process. The post retort debris consists of broken glass ampules. The debris is tested for residual mercury to document the removal of the mercury to levels below the US EPA Land Disposal Restriction (LDR) levels. The debris is then disposal of as a non-hazardous solid waste at Advanced Disposal Glacier Ridge Landfill, LLC in Horicon, Wisconsin.

A site evaluation of the Veolia Processing Center in Port Washington, WI was conducted by TRC's operations and compliance manager, Danielle Myers, in late October 2019. An audit is scheduled to be completed every two years.
