

LETTER FROM THE EXECUTIVE DIRECTOR

2020 has been a very difficult year for many in our country. The COVID-19 pandemic and its impact on all aspects of our personal and professional lives is hard to calculate. As we reflect on the accomplishments that were achieved in 2020, we must also understand that the pandemic's effects will continue to be felt well into 2021 as well. However, despite the difficulties experienced during this most unusual year it is important to consider how much activity TRC was able to execute in the last year. The program continued to work in new and interesting ways to keep collecting mercury-containing thermostats and recycling every mercury thermostat every time.

While overall 2020 collections are down, data shows that the replacement of HVACR equipment continues to be the leading indicator to mercury thermostat replacement. The accelerated adoption of "smart-home" controls and the array of utility programs which encourage early thermostat replacements continue to be major drivers of collections. Looking ahead, TRC anticipates that the program will experience a rebound in 2021 collections as site visits can be utilized in a greater capacity to encourage the return of mercury containing thermostats. However, it is important to remember that TRC collects and recycles a product that has not been sold in the marketplace since 2007; and as there is a decreasing number of mercury-containing thermostats in use, our collections will continue to decline.

TRC was able to fulfill state statutory requirements, agreements and other arrangements for regulatory and legislative compliance, despite the strain our country experienced in 2020. In 2021, TRC will continue to target mercury thermostat collections with utility energy efficiency programs while simultaneously maintaining the HVAC industry collections. TRC plans to work with its partners in industry, the waste sector, the energy sector and the regulatory community to achieve positive results.

The message around the importance of the proper disposal of mercury-containing devices is really a familiar message. As with any recycling program, our goal is to maintain awareness of the issue without becoming background noise lost in the constant stream of marketing information broadcast

each day. One exciting change coming to TRC in 2021 will be a redesigned website, built to better target individual recyclers and homeowners as well as expanded mobility functions.

For a program such as TRC's to be successful year after year, the coordinated effort of many parties is required. TRC is fortunate to have exceptional support from its industry members, collection partners, marketers, allied industries, regulatory agencies and staff. These strategic partnerships allow TRC's effectiveness to grow as it continues to move forward successfully in the collection and proper disposal of mercury-containing thermostats.

2020 Collections and Evaluation

The following analytical report details the annual program performance for mercury thermostat collection in the state of Iowa in 2020. It is important to note that collections were most likely affected by the pandemic, whether it be fewer in-home replacements, a delay of dropping thermostats off for recycling or collection locations returning less recycling containers due to limited personnel. A few of the program highlights for 2020 are included below:


- In 2020 the program **collected 10.6 lbs. of mercury** in Iowa. Since 2000, the annual quantity of mercury collected in Iowa has been an average of 20.1 lbs.
- The program collected 850 whole thermostats in 2020. This was a 6% decrease over the number of thermostats collected in 2019. Since 2000, the average thermostat count per year is 2,223.
- The number of whole thermostats collected per bin in 2020 was 31 thermostats, a decrease from 42 in 2019.
- The counties with the most bins and thermostats returned in 2020 were Polk County (4 bins, 206 thermostats), Scott County (5 bins, 167 thermostats), and Woodbury County (2 bins, 100 thermostats).
- In 2020, 80% of the partner locations returned at least one bin.
- A total of 82 'Miss You' calls were placed. No site visits were completed in 2020. The "Miss You' calls resulted in a positive relationship of activity to bin returns.
- In addition to 850 whole thermostats, 588 loose switches were collected, bringing the total number of "thermostat equivalents" returned in 2020 to 1,298, a decrease of 74% from 2019.

Section 1: Program Analytics

Section 1 of this report examines the annual performance of the thermostat collection recycling program in terms of bins, thermostats, and mercury collected as well as the year-over-year progression of the program. On average, the program has collected 19.7 lbs. of mercury and 2,223 whole thermostats per year since 2000. In 2020, the program collected 10.6 lbs. of mercury from 850 thermostats and 588 loose switches. Figure 1 displays the total number of bins, the total number of thermostats, and the quantity of mercury collected in lowa since the beginning of the program.

Figure 2 displays the number of bins collected in Iowa since the initiation of the collection program, as well as the total number of bins collected in the U.S. over the same period. The number of bins collected in Iowa has generally increased from 2000 to 2011. In 2014, bin returns increased again, peaking with highest number of bins returned in 2015 with 63 bins.

The 10.6 lbs. of mercury collected in Iowa in 2020 was 73% lower than the 39.2 lbs. collected in 2019. Figure 3 displays the quantity of mercury collected in Iowa over time as well as the annual percent change in Iowa and nationally.





Figure 5 - Whole Thermostats Collected in Iowa and Nationally Over Time and Annual Percent Change

lowa collected 850 thermostats in 2020. This was a 60% decrease over the number of thermostats collected in 2019. Figure 4 displays the total number of thermostats collected in lowa and nationally, and Figure 5 shares the underlying data as well as the calculated annual percent change.

Figure 6 displays the monthly distribution of bins and thermostats collected in Iowa in 2020. The months with the greatest number of thermostats returned were February (207 thermostats, 4 bins), and May (172 thermostats, 6 bins). The month with the greatest number of bins returned was January (7 bins). Conversely, the months with the least activity in 2020 were July and August.



The highest number of thermostats per bin returned occurred in September (93 thermostats per bin). Figure 7 shows the average number of thermostats per bin returned per month for the year.




Figure 8 displays the average number of thermostats returned per bin in Iowa and in the U.S. since the beginning of the Iowa program. Nationally, the number of thermostats per bin has been decreasing annually since 2000. In Iowa a similar pattern is observed, apart from a few years. The number of thermostats per bin in 2020 (31 thermostats per bin avg.) decreased from 2019 (42 thermostats per bin avg.).






Figure 9 plots the total bins returned over time along with the average number of thermostats per bin over the same period. In general, the number of bins returned in Iowa increased steadily from 2000 to 2015. A negative correlation has been identified between the number of bins returned and the number of thermostats per bin.




SECTION 2: Channel Partner Analysis

Section 2 of the report examines the partner locations in more detail. Many of the thermostats collected in Iowa were through wholesalers (59.6%) and HHWs (39.5%). Figure 10 shows the distribution of thermostats collected by location type in 2020.



The number of bins returned in 2020 decreased from 2019 levels across all location types. Figure 11 displays the change in the number of bins returned by thermostat collection type over time in Iowa.



In 2020, 80% of Iowa locations possessing a collection bin sent back at least one bin for recycling. The distribution is displayed in Figure 12.




Figure 13 displays the total bins and thermostats returned by county in 2020. An analysis of the top performing counties revealed that Polk County (4 bins, 206 thermostats), Scott County (5 bins, 167 thermostats), and Woodbury County (2 bins, 100 thermostats) returned the greatest number of bins and thermostats in 2020.

TRC partner Johnstone Supply (205 thermostats) returned the highest number of thermostats in Iowa in 2020, followed by Scott Co Rcc (96 thermostats) and Dennis Supply Co (93 thermostats). Apart from these locations, 3 program partners returned more than 50 thermostats each. Figure 14 displays the top performers in terms of total thermostats returned in 2020.



TRC conducted several activities in 2020 to increase the number of bins and thermostats returned in lowa. These activities included 'miss you' calls to collection locations that may not have returned a bin recently. In 2020, no site visits were conducted in lowa, and a total of 82 'miss you' calls were placed. Figure 16 displays the relationship between the number of site visits per month, the bins returned per month, and the number of thermostats (in 100's) returned per month.





Figure 17 displays the relationship between the number of calls per month, the bins returned per month and the number of thermostats (by 100's) returned per month. Calls were placed in the month of July.



SECTION 3: Comparisons to National and Other States' Data

To compare how the Iowa collection partners performed in 2020, the national average for the number of bins returned per location that returned at least one bin was calculated and compared to the Iowa average since 2012. The average number of bins does not include locations that did not return any bins in that year. It should be noted that when making comparisons each state has different regulations, different housing types, local policies, and incentives that may have a unique impact on returns. Overall, the average number of bins returned per location per year was lower in lowa than the U.S. average. However, recently the averages have come closer together as shown in Figure 19.



Figure 22 displays total percentage of locations that actively participated in the program (active participation defined as sending back at least one bin) in 2020, for all the states that mandate thermostat returns reporting as well as the U.S. national average for all states (reporting and non-reporting). In 2020, 80% of the locations in lowa returned at least one bin compared to a national average of 77%. The highest percentage of locations returning a bin in 2020 amongst states that mandate thermostat returns reporting was New Hampshire (82%).




Figure 23 compares the lowa and national rates for several analytics. These include: total whole thermostats, bins, and loose switches collected, number of thermostats collected by total locations and per actively participating locations, number of thermostats per bin returned on average, equivalent average, number of mercury thermostat equivalents returned in 2020, and finally percent change in mercury thermostat conversion from 2019 to 2020. The equivalent average is an average of the number of switches in whole thermostats collected in lowa, and it is used to represent an equivalent number of thermostats from returned loose switches. The thermostat equivalent number includes the totals of whole thermostats returned plus the number of thermostats estimated from loose switches. The states displayed are those that mandate thermostat returns reporting and the U.S. average is for all states that return bins (reporting and non-reporting).

2020 Collections by Brand

In Iowa, Thermostat Recycling Corporation (TRC) recovered the equivalent of 1,298 mercury thermostats from 850 whole mercury thermostats plus 588 mercury switches removed from thermostats. A total of 10.6 pounds of mercury was diverted from solid waste. *Please note the explanation of the converted thermostats or thermostat equivalents below.¹ An example of the mercury ampoule is shown below.



As required by the state statute, a table of thermostat brand holders with their corresponding thermostats, the number of switches and the pounds of mercury recycled is below. It is important to note that there remain non-members whose thermostats the TRC collection program recycles. They are listed in the table as "Non-Member Brands".

otherwise known as the conversion ratio. After the conversion ratio is calculated, TRC will multiple the loose mercury switches by the conversion ratio. Lastly, we add this result to the whole (intact) thermostats to produce the converted thermostats or thermostat equivalents.

¹ A mercury thermostat contains a variable amount of mercury ampoules or "switches" attached to the subbase of the thermostat. These glass ampoules often are collected in the recycling container without the intact thermostat attached to them. TRC collects and counts these loose ampoules and recycles them. To derive the converted thermostat or thermostat equivalent, the program takes the following calculations to develop the converted thermostat or thermostat equivalent. First, TRC will count the total whole (intact) thermostats collected in the recycling bins. From these units, there is an intact ampoules count. TRC then takes the intact ampoules divided by the whole (intact) thermostats or

2020 Summary of the Program Expenses

Below is a summary of program expenses for the lowa collection program in 2020. 2020 program expenses (reported in the annual report) are unaudited and are for management purposes only. Prior to submittal of this annual report, the expenses were reviewed by Kellen Company.

Current Collection Locations

Small Pails and Green Bins

In 2020, TRC shipped 25 small pails to collection points around the country. We also shipped 159 new green bins. In comparison, the program shipped 291 new green bins in 2019 and 55 small pails². Collection locations either requested the new pail when they signed up to participate in the program or chose to switch out their bin with a pail due to decreased collections. The large green bins which have been the staple of the program continued to be replenished as they were returned for processing. Because the containers are reused and bar coded, we anticipate that the request for new containers will continue to decrease as the program operates.

• Of the totals provided, TRC did not ship any containers to Iowa.

Collection Location Outbound Phone Calls

Our outbound phone calls have been branded internally as the "Miss You Call" process. These calls promote collection container returns and serve as a reminder to locations that have not returned any thermostats. TRC allocates these "miss you calls" to collection sites that have not returned a container in over a year. These calls serve as a friendly customer service check to see if any of the program materials need to be replenished or if missing containers need to be replaced. In total, the program called 4,175 current collection locations in 2020, compared to 3,557 in 2019.

Completed 82 calls to encourage shipping the recycling container compared to 109 a year
 prior. A copy of the locations called can be found in the Appendix.

Collection Location Postcards

TRC updated the reminder postcard design mid-2019 to encourage locations to heed the message. The postcards are sent to all locations that have not returned a container in the past year. In 2020,

² New bin orders coincide with accounts that open new stores, move or lose their existing containers.

TRC mailed 12,963 postcards. By updating the look of these postcards, TRC hoped to engage locations that were familiar with the old design and may have disregarded it in the past.

Mailed 224 reminder postcards compared to 154 a year prior.



Collection Location Emails

TRC emailed locations three weeks after receiving a postcard to encourage them to directly ship the recycling container. These emails contain step-by-step instructions for shipping and direct contact information for missing shipping labels or further questions.

• Emailed 64 collection locations three weeks after receiving the reminder postcard to ship their container.

Collection Location Site Visits

Throughout the year, 1,781 site visits were completed in numerous states. The purpose of site visits is to inform the location of their requirements in participation, what the statute requires of them, shipment of the recycling container, and to answer any questions they may have. Often, valuable information is gathered during the site visit which is used to enhance TRC's outreach and update the database with current contact details. With the pandemic, TRC refrained from visiting locations inperson for a few months. For locations scheduled to receive a visit between March and August we "virtually visited" those locations via phone or meeting, rather than cancelling the visit altogether.

HVAC Industry

The HVAC industry is arguably still the best, most productive and most engaged channel for recycling mercury containing thermostats. We consider this industry to be the manufacturers, wholesale distributors, and contractors which are intimately involved with the recovery of mercury thermostats. TRC took the following actions:

- TRC was spotlighted in HVAC Refrigeration Daily, a print magazine distributed at the International Air-Conditioning, Heating, Refrigerating Expo.
- Continued the "Banish Mercury Off the Planet" (BMOP) Competition encouraging all HARDI wholesalers to compete through collections. Included direct marketing to 2,714 HARDI HVAC members.
 - The annual competition recovered 222.95 pounds of mercury from 166 HVAC wholesalers. More than 350 branch locations returned collection bins during the contest period.



- TRC appeared on radio shows to promote the program and National Recycle Your Mercury
 Thermostat Day. Both Hammertime Radio in Buffalo, NY and The Future of Real Estate in
 Tulsa, OK featured TRC and our mission in October of 2020.
- TRC was featured on Season 2, episode 43 of the HVAC Jerks Podcast titled "Mercury in the Green Box, Please". The episode focused on TRC's history, program and what the future holds.

Utility Industry

In 2020, TRC continued its approach to engage the utility sector, specifically targeting actions toward the utility companies themselves and the installer/implementer. Each of these audiences have distinct messaging requirements and informational needs.

- Exhibited at two conferences targeting the utility industry before the pandemic halted inperson events.
- Sent 424 informational emails to known utility implementers on the program.

Waste Related Sector and Household Hazardous Waste (HHW) Industry

The waste-related sector remains an important sector for TRC to target individuals and those residents performing DIY thermostat installations. These attempts were to gain new collection locations, form better relationships with the audience and raise overall awareness of the TRC program. As a result of these learnings, TRC took the following actions:

- Scoured google alerts for HHW events to target phone call or email outreach to encourage them to use program. Sent 16 emails to facilities, offering a free container.
- Advertised in the national North American Hazardous Materials Management Association
 (NAHMMA) News Brief, reallocating funds planned for the conference.

In 2020, TRC updated the zip code locator on the website to provide information regarding pandemic protocols. While most collection locations remained open, certain operations were most likely adjusted to accommodate for social distancing. Therefore, we recommended all recyclers should contact the collection location beforehand.

In the fall of 2020, TRC began a website redesign project that will enhance mobile accessibility and better navigation for website users. TRC expects to launch the updated website in the spring of 2021.

Search Engine Marketing (SEM)

Search Engine Marketing (also SEM or pay per click—PPC) is the process of buying a paid position on the search engine results page. TRC refined its strategy for SEM in 2020 with very promising results.

Impressions and clicks went down when compared to 2019, but the overall click-through-rate went up, which means a higher percentage of people are engaging with TRC's ads and that TRC is reaching the right audience.

The focus for TRC's SEM strategy is conversions, which are counted when someone navigates to the Find a Thermostat Collection Site page on the TRC website. In this area, there was very positive

improvement for 2020 in the number of conversions, the cost per conversion, and the conversion rate.

In summary, overall, more qualified leads came to the TRC website in 2020.



Search Engine Optimization (SEO)


Search Engine Optimization (SEO) is the process whereby a website is optimized through original content and on-site coding tactics to increase its chances of appearing near the top of "organic searches." An organic search is one that appears "naturally" in a search engine like Google or Bing. In other words, an organic listing is not ranked through paid search.

Organic traffic to a website typically brings visitors who stay longer, and visit more pages, on average.

Two key measures were identified as a baseline for growth. They are:

- Clicks from organic search
- Page-one organic terms

In 2020, organic search traffic yielded 7,460 clicks to the TRC website. By comparison, there were 6,427 clicks from organic search over the same time period in 2019.



In 2020 TRC had 298 organic search terms ranked on page one of a Google search, a small decrease compared to 334 page-one keywords in 2019. As TRC goes through a website redesign in Q1 of 2021, SEO is being refreshed for enhanced performance moving forward.

HOW MERCURY THERMOSTAT WASTE IS HANDLED

WASTE MERCURY-ADDED THERMOSTAT MANAGEMENT THROUGH VEOLIA ES TECHNICAL SOLUTIONS, LLC.

TRC containers with waste mercury-switch thermostats are received at a fulfillment/inventory center in Port Washington, Wisconsin (WIR000130591). The facility is owned and operated by Veolia ES Technical Solutions, L.L.C. (Veolia) under contract with TRC.

All recycling containers, including pails and bins are received at the loading dock and sent to the TRC inventory room. The container and plastic liner are opened and the contents are identified, sorted, and tallied. The following data is recorded for each bin returned and processed: bin number, business name (location name), city, state, zip code, date returned, number of thermostats and mercury switches by manufacturer and any non-conforming material.

The containers are returned to the location that sent it in with a new prepaid address label within 3 weeks of receipt. The thermostats are stored and staged in a plastic lined carton in a storage area for final processing. The containers are dated and processed in order received, first in-first out.

The thermostats and any loose bulbs collected from the containers are consolidated into a special 55-gallon drum which is labeled and dated according to regulations. The drum is sealed with a band and is only opened when contents are being added to it. Special negative pressure venting assures any fumes are captured and vented when the drum is opened.

The 55-gallon drum is then shipped to Veolia's mercury recovery facility (WID988566543) for final processing of the mercury ampules (switches). Veolia Environmental Services meets or exceeds all local, state, federal and EPA regulations for the management of the product.

The containers are returned from the storage area to the mercury recovery processing area to have the mercury bulbs removed from the plastic housing. Universal Waste Regulations require the recycling and disposal of waste within 12 months of acceptance at the processing facility.

Small quantities of thermostats are removed from the container, which is then closed again. The bulbs are removed from the thermostats and placed into processing vessel at the work station. Once the processing vessel is full, the vessel is loaded into the mercury recovery retort oven.

If a bulb breaks and the mercury spills, the work area is designed to contain the spillage and the operators are trained in the clean-up and disposal of mercury. The TRC inventory

and processing areas are equipped with special mercury vacuum cleaners and the work area is vacuumed at the end of the work day to ensure that any spillage is cleaned up and not left to evaporate.

Veolia meets or exceeds all local, state, federal and EPA regulations for the management of the product. The mercury recovery facility and process are permitted by the Wisconsin Department of Natural Resources. Veolia's approvals for mercury recovery/recycling include:

- EPA identification WID988566543
- Hazardous Waste Storage License #6008
- Hazardous Waste Treatment License (Mercury Recovery Operations) #4585
- Air Operation Permit #246076050-S01
- Storm Water General Permit #WI-S067857-4

In addition to the regulatory permits, both Veolia Port Washington facilities have developed and maintain management systems in accordance with ISO 14001-2004, OHSAS 18001-2007, and Responsible Recycling (R2:2013) Practice. All persons who handle mercury thermostats as part of the TRC operation receive training in the handling of Hazardous Waste and Universal Waste.

The mercury containing ampules are retorted at Veolia's Port Washington Mineral Springs facility. The mercury is removed during the retort process. The post retort debris consists of broken glass ampules. The debris is tested for residual mercury to document the removal of the mercury to levels below the US EPA Land Disposal Restriction (LDR) levels. The debris is then disposal of as a non-hazardous solid waste at Advanced Disposal Glacier Ridge Landfill, LLC in Horicon, Wisconsin.

A site evaluation of the Veolia Processing Center in Port Washington, WI was conducted by TRC's operations and compliance manager, Danielle Myers, in late October 2019. An audit is scheduled to be completed every two years.
